# **Carol Tullett:**

9. In Mitchell Shire, plans are being made to accommodate rapid growth in our population in parallel with Melbourne's growth. As a Councillor, would you encourage the increasing rate of growth, and how would you manage the opportunities and impacts of this growth of our towns and countryside?

## **Rhonda Sanderson:**

The southernmost part of the Shire is within Melbourne's Urban Growth Zone and will continue to experience growth in line with State policy. Our other major towns are listed in the Hume Regional Growth Plan and Plan Melbourne as sites for future growth. We need to responsibly plan for the growth so that it is managed and contained within township boundaries and is not ad hoc.

Managing the opportunities/impacts would include: encouraging environmentally sustainable design (eg water saving, energy saving), creating 20 minute communities where practicable, encouraging active transport (footpaths, bike paths, trails) and public transport, urban forest strategy, sufficient open space, protect waterways.

# **General responses**

# **Fiona Stevens:**

I have spoken on and supported improving our representation in the areas you (BEAM) hold interest in.

### Carol Tullett

I am sorry that I have not answered your questions.

I feel some answers can be opinions only because as a Councillor I would be one of nine and as such the majority are needed to pass recommendations.

I will present arguments to try and gain support for recommendations that reflect the interests of the community.

What I can do here is to give you some idea of what I have done in the past so that your members can get some idea of my environmental creds.

In 1992 I graduated from the University of South Australia with a degree in Business Management. While doing this degree I studied a subject called 'Environmental Dilemma' and due to my nursing background I did a paper on "Disposable Nappies - Friend or Foe". It was very interesting and I learnt a lot. I had already been interested in our impact on the environment that's why I chose this subject. When going to the beach my friends would not walk with me because I would go with a bag picking up all the rubbish and delve into bins to get the cans since they could be recycled. I had some interesting nick names. I was also growing plants for wildlife and helping farmers and landholders plant the trees I'd grown.

After this I lived in Sydney where I would drag family and friends to tours of tips and recycling centres in Western Sydney. Again very interesting and at one tip I was astonished to see how this huge hole in the ground was nearly 3/4's full after just 18 months of operation.

We arrived in Seymour in 2002 and our son started Prep at the then Green School. By the next year I was able to organised the first tree planting day for Planet Ark by the school. I did this for the next couple of years until my son changed schools and then I organised it for his new school. During the time spent at the Green School I was allowed for a couple of years to conduct classes on Environmental Issues for the 5/6 classes to fit in with their curriculum.

I can't remember the years in which the Council ran the Sustainable Communities program but I was a regular attendee. I enjoyed seeing the 'House of Straw' in Kilmore, the property outside of Violet Town that did not use any energy off the grid and much more. It was a real shame that this program was discontinued. I certainly would love to see something like this up and running again since it gave people information so that they could make better choices.

I have not lost my enthusiasm about my regard for looking after the environment and lessening our impact but life sometimes has a way of deviating your focus.

I know that this is not what you and your members wanted but I hope that what I have written helps you understand some of my core values.
